- Release 4 scheduled for November 12, 2021




### **Cash Management**

#### **Matching Rules**

- Improved grouping can now group bank transactions, not just Intacct transactions
- Can create rule that only looks at specific bank transactions
- Additional operators in the filter and matching conditions
- Flexible date comparisons using matching operator of 'within'

## **Financial Report Writer**

- New normalized columns help by showing whether negative or positive variances are favorable or unfavorable
- Addition of spacer columns (Keep in mind these count as column for computations)
- Easily identify a report and its contents in the QuickStart library



### **Secure PDF**

- Prevents altering of electronically printed documents
- No one can edit, sign, copy extract or comment on the PDF
- Setting is on the printed document template

### **Enhanced Contracts Billing**

- Contract Usage Billing subscription to support an additional type of quantitybased billing: Committed quantity.
- Enable line level 'Bill to' contact (Contracts only), so that you could start specifying different bill-to contacts for different contract lines in the same contract.

### Subscription to Canadian Sales Tax

- For new instances of Sage Intacct for Canadian customers,
  - Canadian Sales Tax is available for subscription at no cost
- For existing Canadian customers,
  - We submit a case to expose the Tax solution at no cost to the customer
  - Customer will need some assistance for implementation
  - Must disable Advanced Tax as a Tax Solution within 90 days of case to avoid future billing events for having two tax solutions enabled
